**SUBJECT:** Abandoned Vehicle Information Service

Effective today, the Motor Vehicle Division has established a **new web-based service** for qualified subscribed users to apply for and receive “**Abandoned Motor Vehicle Record Responses**”. This new service is being provided as an alternative to the current process which requires a person in possession of an abandoned motor vehicle to complete and submit the Abandoned Motor Vehicle Record Request form (MVT 32-13) through the mail. **It is important to note that the new service will provide a record response immediately at the time the inquiry is made.** A control number will be added to each response generated by this system in the top right hand corner of the record response and the attest name will appear as ALVIS. In addition, the Alabama Great Seal appears in the center of the form. Below is a link to new the subscription service.
