### ORDINANCE NO. 2018-11

#### An Ordinance to Amend Ordinance 1994-1012.

BE IT ORDAINED by the City Council of the City of Alexander City, Alabama, as follows:

WHEREAS, the City of Alexander City, Alabama, ("the City") presently has an Ordinance (No. 1012) which generally prohibits the distribution and consumption of alcoholic beverages on City properties; and

WHEREAS, the City has adopted an Ordinance (No. 2015-11) creating an Arts and Entertainment District which provides for the distribution and consumption of such beverages on City property if all requirements of the Arts and Entertainment District Ordinance are met; and

WHEREAS, the City owns the public golf course known as Lakewinds Golf Course which is licensed to distribute alcoholic beverages by the Alabama Beverage Control Board (ABC); and

WHEREAS, the City has leased or plans to lease in the future certain properties to tenants who desire to distribute alcoholic beverages to their customers or members;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Alexander City Alabama, as follows:

WHEREAS, the City Council desires to clarify Ordinance No. 1012 and to remove any conflict with Ordinance No. 1012 and the Arts and Entertainment District Ordinance (No. 2015-11) as well as the Lakewinds Golf Course and other leased premises to distribute alcoholic beverages, Ordinance No. 1012 is hereby amended as follows:

Ordinance No. 1012, (prohibition of alcohol on specified City property) is hereby amended by deleting the following phrase:

"provided that such term shall not mean nor include premises which have been duly licensed by the City of Alexander City, Alabama, for sale thereon of such beverages" and substituting the following language:

"provided that such term shall not include City owned streets or leased premises which are a part of the Arts and Entertainment District pursuant to Ordinance No. 2015-11 or City owned premises leased to a person or entity which has an ABC license to distribute alcoholic beverages".

**THEREFORE**, the Ordinance No. 1994-1012 shall read as follows:

**SECTION 1.** It shall be unlawful for any person to drink or have in open or unconcealed possession, or custody, for drinking, selling, serving, dispensing, or give away; or attempting to drink, sell, serve, dispense, or give away, any liquor, wine or malt brewed beverages, while upon any street, avenue, or alley, or in any public building or upon any property, or while in any other public place in the City of Alexander City, Alabama. As used in this section, the term "public place" shall mean and include any place or gathering which the public generally attends or is admitted to either by invitations, common consent or right, or by payment of an admission or other charge, and, without limited the generality of the foregoing, shall include any theatre or other place of amusement and any contest; provided that such term shall not include City owned streets or leased premises which are a part of the Arts and Entertainment District pursuant to Ordinance No. 2015-11 or City owned premises leased to a person or entity which has an ABC license to distribute alcoholic beverages".
