Jefferson County Vehicle Registration, Renewal, Transfer and Vehicle Property Tax Payment Deadlines Extended to Include November Registrations

Montgomery—State Revenue Commissioner Tim Russell announced today that the November 2009 motor vehicle registration, renewal, transfer and vehicle property tax payment deadlines have been extended through December 2009 for Jefferson County residents affected by the recent county office closings and office understaffing.

In an order issued on Nov. 12, 2009, State Revenue Commissioner Tim Russell amended his original order dated Aug. 4, 2009, to include the November motor vehicle registration, renewal, transfer and vehicle property tax payment period until Dec. 31, 2009, for Jefferson County residents. Jefferson County residents renewing or transferring their vehicles' annual November registrations during this extended period will not be subject to any penalty and interest charges for late registration or late payment of vehicle property tax until Jan. 4, 2010.

The amended order now includes August, September, October and November 2009 motor vehicle registration, renewal, transfer and vehicle property tax payment periods.

The November registration renewal extension is also applicable to Jefferson County residents who have recently purchased or otherwise acquired a vehicle during the period July 12, 2009, through Nov. 10, 2009, and have not been able to register their vehicle within the 20-day registration period because of backlogs resulting from recent office closings and staff reductions. The extension order also applies to registration transfers occurring during this period, July 12, 2009, through Nov. 10, 2009.

The ADOR advises that the extension order does not apply to registration fees paid by International Registration Plan (IRP) registrants based in Jefferson County—individuals or companies owning commercial vehicles with a combined gross vehicle weight exceeding 26,000 pounds and used in interstate commerce, as these owners are required to pay all registration fees directly to the ADOR.

The order does, however, apply to the payment of property taxes due by Jefferson County-based IRP registrants during the period August 1 through December 31. The ADOR will issue temporary IRP vehicle registrations to Jefferson County-based IRP registrants upon payment of IRP registration fees that will allow carriers to continue to operate for a limited time. Apportioned license plates will be issued upon presentation of evidence of payment of property taxes to Jefferson County.



ORDER OF THE COMMISSIONER OF REVENUE (REVISED)

Due to the extreme hardships placed on Alabama motor vehicle registrants located in Jefferson County, Alabama, who had very limited access to the county license plate issuing offices or county tax collection offices or experienced processing delays in these offices during the months of August, September, October and November 2009, when attempting to register, renew or transfer registrations for their motor vehicles and pay property taxes on their vehicles because county courthouses and other county offices were understaffed during some or all of this timeframe, under the power granted to me by §40-2-11, Code of Alabama 1975, I hereby issue the following order:

I. GENERAL RULE

(a) EXTENSION OF TIME FOR REGISTERING, RENEWING OR TRANSFERRING AUGUST, SEPTEMBER, OCTOBER AND NOVEMBER 2009 MOTOR VEHICLE REGISTRATIONS AND PAYING PROPERTY TAXES ON VEHICLES. For the purposes of applying Alabama's motor vehicle registration laws and property tax laws as related to the annual registration renewal of vehicles during the months of August, September, October and November 2009, the registration deadline has been extended through December 31, 2009, without payment of penalty or interest for vehicle owners located in Jefferson County where the county courthouse or other county license plate issuing offices and county tax collection offices were understaffed during some or all of the months of August, September and October 2009 as a result of county budgetary constraints.

This extension includes the registration of vehicles purchased or otherwise acquired from July 12, 2009, through November 10, 2009, as well as transfers of registrations whereby the 20-day registration requirement as provided for in §32-6-61 and §40-12-260, Code of Alabama 1975, occurs, in part, during the months of August, September, October or November 2009. The extension does not apply to motor vehicle registrations, renewals, or transfers for vehicles registered pursuant to the International Registration Plan (IRP). These vehicle owners are required to pay all registration fees to the Department of Revenue, Motor Vehicle Division, during the assigned registration month. The extension does, however, apply to the payment of property taxes on IRP vehicles.

(b) PENALTY AND INTEREST CHARGES ASSOCIATED WITH REGISTERING, RENEWING OR TRANSFERRING AUGUST, SEPTEMBER, OCTOBER AND NOVEMBER 2009 MOTOR VEHICLE REGISTRATIONS AND PAYING PROPERTY TAXES ON VEHICLES. Penalty and interest charges associated with motor vehicle registrations, transfers and renewals extended through December 31, 2009, will not be charged until January 4, 2010. Additionally, penalty and interest charges associated with motor vehicle property tax payments extended through December 31, 2009, will not be charged until January 4, 2010.
