NOTICE

TO: All Tobacco Distributors Filing State-Administered County Tobacco Taxes

SUBJECT: St. Clair County Tobacco Tax

According to a resolution adopted by the St. Clair County Commission, the Alabama Department of Revenue has been designated as the agency to collect St. Clair County tobacco taxes. **The appropriate tax is to be collected and remitted to the Alabama Department of Revenue beginning with the July 2018 return which is due no later than August 20, 2018.** The Alabama Department of Revenue is authorized to promulgate and enforce rules and regulations for the administration of the taxes levied by St. Clair County Acts and Chapter 25 of Title 40, <u>Code of Alabama 1975</u>. The taxes levied are 10% of the state tobacco rates and are as follows:

Cigarette tax will be collected by affixing a St. Clair County revenue stamp. These stamps are not currently available. Taxpayers will be notified when the cigarette tax stamps are available for purchase from the Alabama Department of Revenue. Therefore, until St. Clair County cigarette tax stamps become available, the cigarette tax must be remitted on the county tobacco tax return via https://myalabamataxes.alabama.gov/ (MAT) until further notice.
