Stamps: County stamps are available in rolls of 15,000 which are machine applied, and sheets of 100 applied by use of a hand iron. Stamps must be purchased in full roll and full sheet quantities.

***Discount:** A 4.75% discount is allowed on stamp purchases made by qualified wholesalers with a tobacco stamping permit **ONLY**. Insufficient payments will result in loss of the discount and penalty and interest charges will be applied.

DO NOT combine state stamp payments with county stamp payments.
