LOC for License Plates Committee May 29, 2013 Alabama State House Room 304

The LOC for License Plates met on Wednesday, May 29, 2013 at 10:00 a.m. in Room 304 in the Alabama State House. Senator Gerald Dial called the meeting to order and asked that the roll be called:

Senator Dial announced there was a quorum present and welcomed members and guests. He then welcomed new committee member, Oline Price, Revenue Commissioner in Lee County who is replacing Judge Luke Cooley. Senator Dial then welcomed new member, Andy Farquhar from Corrections who is replacing Don Segrest.

Senator Sanford made a motion to approve the minutes from the last meeting. Representative Clouse seconded the motion.

Motion passed by voice vote

Senator Dial then began to discuss the "Mega Bill", House Bill 215 or Act No 2013-298 passed in the 2013 Regular Session.

Senator Dial called on Brenda Coone from the Revenue Department to discuss HB215.

Brenda Coone discussed several parts of the bill:

Sections 3 and 4 took effect immediately

- Present ID for only one owner to renew tags
- Repeal 40-12-267 because it is obsolete

Code Sections take effect January 1, 2014

- Permit LOC to approve motorcycle applications
 Only Quanity Class 2 must sell 1000
- Out of state colleges and universities can apply for a distinctive license plate
- Allows for online ordering in the pre commitment phase
- Changes the distribution of proceeds from the National Guard Plate
- Allows Retired Volunteer Firefighters from other states that now live in Alabama to get a Retired Firefighter tag
- Provides for Law Enforcement License Plate

Brenda Coone gave a status report on organizations and where they are on their pre commitments.

Ben Bowden asked about the money for tags when the organization does not sell required number of tags.

Brenda Coone explained that the money goes back to the sponsoring organization and it is up to them whether to return the money to the individual or retain it. Senator Dial noted that that was not law and strictly up to the sponsoring organization.

Ben Bowden questioned the partnership with Alabama Power.

Mr. Cook explained that the Conservation Foundation has been established and Alabama Power has deposited money into the Foundation to finance 1100 tags.
