

# **Accessing the Wholesale to Retail Accountability Program (WRAP) data on the Local Reports Site**

ACT 2017-294 known as the Wholesale to Retail Accountability Program (WRAP) requires each beer, wine and tobacco wholesaler licensed by the ABC Board to submit an informational report to the Alabama Department of Revenue. This report details all wholesale sales of Beer, Wine and Tobacco products made to retailers for resale for each monthly reporting period. The act further establishes that the Alabama Department of Revenue will make this data available to municipal and county governments.

## **Where to access the WRAP data:**

The data has been added to the existing Local Governments' Online Reports site <https://revenue.alabama.gov/sales-use/#info4localgovt>. After logging in, use the "WRAP Reports" link to access the data.

## **Accessing the WRAP data:**

There are three choices for accessing the WRAP data:

1. **Download Monthly Wrap Files** – This section allows all Beer, Wine and Tobacco data to be downloaded by File Date. Each File Date covers data that was submitted by the wholesalers during that filing period and would typically contain invoices from the prior month. For example, a file with a File Date of 12/31/2018 contains data that was submitted from 12/01/2018 through 12/31/2018 and generally contains invoices dated from 11/1/2018 through 11/30/2018. However, it could contain invoices from prior periods that were filed late. Furthermore, it could also contain corrected data that was submitted in subsequent periods. Files that contain corrected data can be identified by the date in the "Last Edited" column.
2. **Custom Tobacco Sales for Resale Report** - This section allows Tobacco data to be downloaded for a specific invoice date range, address, city, zip code, state sales tax number, customer name or wholesaler name. Up to 100,000 records can be retrieved with each search. The results can then be printed or exported for offline use.
3. **Custom Beer & Wine Sales for Resale Report** - This section allows Beer and Wine data to be downloaded for a specific invoice date range, address, city, zip code, ABC License Number, Customer Name or Wholesaler Name. Up to 100,000 records can be retrieved with each search. The results can then be printed or exported for offline use.

## **Additional Information:**

- **Amended Data** - Wholesalers can amend each period's WRAP data at any time. When the data is amended all previously submitted data from that wholesaler for the period is discarded and completely replaced with the new data. Therefore, when using the file download section, it is important to note the "Last Edited" date to identify any files that may need to be downloaded again to receive the updated information.

- **Record Availability** - Each locality has access to the data for businesses located in their city or county. Access to each record is determined by the zip code submitted with each record by the wholesaler. Since zip codes often cover multiple cities and counties each report could contain data for businesses that are not located in the selected city or county. All localities located within the zip code listed in the record will have access to the data for that business.
- **Beer & Wine Data Detail** - The Beer and Wine data contains a single line of data for each invoice. Each row shows the total amount of the invoice.
- **Tobacco Data Detail** - The Tobacco data contains a separate row for each line item of each invoice.
- **Frequency of Updates** – New WRAP data is made available around the 5<sup>th</sup> business day of each month.
