## **ORDINANCE NO 982**

## AN ORDINANCE TO AMEND THE CODE OF ORDINANCES, ADOPTED NOVEMBER 6, 1995, AT CHAPTER 6 BUSINESS LICENSES, TAXES AND REGULATIONS, ARTICLE VIII, LODGING AND ACCOMMODATIONS TAX, SECTIONS 6-151 AND 6-152, LEVY OF TAX BY CHANGING CERTAIN LANGUAGE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA, WHILE IN REGULAR MEETING ASSEMBLED ON AUGUST 20, 2018.

Section 1. That Chapter 6, BUSINESS LICENSES, TAXES AND REGULATIONS, of the code of Ordinances, adopted November 6, 1995, be and it is hereby amended by changing certain language at ARTICLE VIII, LODGING AND ACCOMMODATIONS TAX, Sections 6-151 and 6-152, Levy of Tax, so the entire Sections shall read as follows:

CHAPTER 6 BUSINESS LICENSES, TAXES AND REGULATIONS

ARTICLE VIII LODGING AND ACCOMMODATIONS TAX

Sec. 6-151. - Levy of tax in the city.

For the privilege of engaging or continuing within the city in the business activities hereinafter referred to, there is hereby levied, in addition to all other taxes of every kind now imposed by law, and shall be collected as herein provided, a privilege or license tax against the person on account of the business activities and in the amounts to be determined by the application of rates against gross receipts as follows:

(1) There is hereby levied and imposed, in addition to all other taxes of every kind now imposed by law, a privilege or license tax upon every person, firm, or corporation engaging in the business of renting or furnishing any room or rooms, lodgings, or accommodations to transients in any hotel, motel, inn, tourist camp, tourist cabin or any other place in which rooms, lodgings, or accommodations are regularly furnished to transients for a consideration, in an amount to be determined by the application of the rate of seven percent of the charge for such room, rooms, lodgings, or accommodations, including the charge for use or rental of personal property and services furnished in such room. The tax shall not apply to rooms, lodgings or accommodations supplied for a period of 30 continuous days or more in any place.

Sec. 6-152. - Levy of tax in the police jurisdiction.

For the privilege of engaging or continuing in the business activities hereinafter referred to within the police jurisdiction of the city outside of its corporate limits, there is hereby levied, in addition to all taxes of every kind now imposed by law, and shall be collected as herein provided, a privilege or license tax against the persons on account of the business activities and in the amounts to be determined by the application of rates against gross receipts as follows:

(1) There is hereby levied and imposed, in addition to all other taxes of every kind now imposed by law, a privilege or license tax upon every person, firm, or corporation engaging in the business of

renting or furnishing any room or rooms, lodgings, or accommodations to transients in any hotel, motel, inn, tourist camp, tourist cabin, or any other place in which rooms, lodgings, or accommodations are regularly furnished to transients for a consideration, in any amount to be determined by the application of the rate of three and one-half percent of the charge for such room, rooms, lodgings, or accommodations, including the charge for use or rental of personal property and services furnished in such room. The tax shall not apply to rooms, lodgings, or accommodations supplied for a period of 30 continuous days or more in any place.

Section 2. That this Ordinance shall become effective October 1, 2018, with the first payment of the tax due and payable on the 20<sup>th</sup> day of November, 2018.
