

ORDINANCE NO.16-4268

WHEREAS, Act 2016-391 recently passed by the State Legislature and becoming General Law authorizes the City of Decatur to reduce its Police Jurisdiction from three miles to a mile and a half by the adoption of an applicable Ordinance; and

WHEREAS, the City Council finds and determines that the public interest and the general welfare of the City is served by the reduction of the City's Police Jurisdiction to a mile and a half; and

WHEREAS, a City Study Committee, the Planning Commission and City Staff have recommended that the Police Jurisdiction boundaries for the City of Decatur be reduced to a mile and a half;

THEREFORE, BE IT ORDAINED by the City Council of the City of Decatur, Alabama as follows:

Section 1. That the paragraph entitled Police jurisdiction of Section 1-2 of the Code of Decatur, Alabama is hereby amended to read as follows:

"Police jurisdiction. The words "police jurisdiction" mean the territory outside of the corporate limits of the city but within a mile and one half of such limits, but not including territory within the corporate limits of any other incorporated municipality."

Section 2. That the police jurisdiction of the City of Decatur, Alabama is reduced to a mile and one half effective on the first day of January 2017.



That this Ordinance is subject to the provisions of Section 11-40-10 of the Code of Alabama 1975, as last amended by Act 2016-391; and will become effective on January 1, 2017 with the proper prior notices to be given, required filings completed, and other requirements of such Section 11-40-10 met.
