ORDINANCE NO. 1861

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES, ADOPTED JULY 24, 1989, AT CHAPTER 8, BUSINESS LICENSES, TAXES AND REGULATIONS, ARTICLE VII, SALES, USE, LODGING AND RENTAL TAXES, DIVISION 4, LODGING TAX, SECTION 8-201, LEVY OF TAX BY CHANGING CERTAIN LANGUAGE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GULF SHORES, ALABAMA, WHILE IN REGULAR SESSION ON September 25, 2017, as follows:

Section 1. That Chapter 8, BUSINESS LICENSES, TAXES AND REGULATIONS, of the code of Ordinances, adopted July 24, 1989, be and it is hereby amended by changing certain language at ARTICLE VII. SALES, USE, LODGING AND RENTAL TAXES, DIVISION 4. LODGING TAX, Section 8-201, Levy of Tax, so the entire Section shall read as follows:

CHAPTER 8 BUSINESS, LICENSES, TAXES AND REGULATIONS

ARTICLE VII.

SALES USE, LODGING AND RENTAL TAXES

DIVISION 4. LODGING TAX

Section 8-201. Levy of Tax.

There is hereby levied and imposed, in addition to all other taxes of every kind now imposed by law, a privilege or license tax upon every person engaging or continuing in this city in the business of renting or furnishing any room or rooms, lodging or accommodations to transients in any hotel, motel, inn, tourist camp, tourist cabin or any other place in which rooms, lodgings or accommodations are regularly furnished to transients for a consideration, at the rate of seven percent (7%) of the gross proceeds derived from the renting or furnishing of such room, rooms, lodgings or accommodations, including the charge for use or rental of personal property and services furnished in such room; provided, that there is exempted from the tax levied under the provisions of this article any rentals or services taxed under the provisions of Article VII, Division 2, known as the Sales Tax Ordinance. The tax levied under the provisions of this article shall not apply to rooms, lodgings or accommodations supplied for a period of one hundred eighty (180) continuous days or more in any place.

Section 2. That this Ordinance shall become effective May 1, 2018 with the first payment of the tax due and payable on the 20th day of June, 2018.


