With the transition to the new site, it was noted that users who have multiple locality codes are having to download each code individually. Previously, all locality codes for a locality could be downloaded together. This has now been updated and users are now able to download all locality codes for a locality at the same time.

Transition of Some Reports to New Online Reports Site – File Name

For those localities who have a single locality code for local sales/use tax, but also have access to a Single Point code, the file name for their ONE SPOT (OS) records will display with a "0000" as the locality code if they leave their locality selection as "All my localities (ALL)". To display the locality code in the file name, the user must first select their four-digit locality code before

going to the OS page. The data inside the file will be the same (except for the trailer record) whether the locality code is selected before going to the OS page or the code is not selected prior to going to the OS page. However, please note that if your locality's import routines require the code in the filename, it will be necessary to take the extra step to select the locality code before downloading the file.

Information Regarding Taxpayer Relief – COVID-19

The Department of Revenue is waiving some state sales tax late payment penalties both for small retail businesses, whose monthly retail sales during the previous calendar year averaged \$62,500 or less, and taxpayers currently registered with the Department as engaging in NAICS Sector 72 business activities, which includes restaurants. The Department is also waiving some state late payment penalties for lodgings taxes.

The relief applies only to state sales taxes and state lodgings taxes. There will be no changes to the MAT/ONE SPOT filing system or to the ONE SPOT files that are received by your locality. An electronic payment will continue to be required at the time of filing for those filing non-state administered localities through the ONE SPOT system.
