ORDINANCE NO. 2209-19

BE IT ORDAINED by the City Council of the City of Sylacauga as follows:

SECTION 1. Ordinance 2167-15 adopted September 15, 2015; Ordinance 2176-16 adopted September 7, 2016; Ordinance 2184-17 adopted April 18, 2017; Ordinance 2189-17 adopted October 17, 2017; Ordinance 2193-17 adopted November 21, 2017; and Ordinance 2207-18 adopted December 18, 2018 are hereby amended by adding the following language:

In addition, the police jurisdiction of the City of Sylacauga is hereby extended as provided by law with the addition of the above described expansion of the corporate limits of the City of Sylacauga and the boundaries of the police jurisdiction shall expand to the distance provided by law to reflect the newly annexed territory.

SECTION 2. This Ordinance shall become effective immediately upon its adoption by the City Council of the City of Sylacauga, and proper publication of same as required by law.


