**RESOLUTION TO CONTRACT WITH PRA GOVERNMENT SERVICES, LLC d/b/a
RDS FOR THE COLLECTION AND PROCESSING OF RENTAL TAXES FOR

A RESOLUTION OF THE TOWN COUNCIL AND MAYOR OF THE TOWN OF
GERALDINE, ALABAMA TO CONTRACT WITH PRA GOVERNMENT SERVICES, LLC
d/b/a RDS FOR THE COLLECTION AND PROCESSING OF RENTAL TAXES FOR THE
TOWN OF GERALDINE, ALABAMA

WHEREAS, the Town of Geraldine has been presented with a proposal by PRA Government Services, LLC d/b/a RDS (hereinafter RDS) whereby RDS will perform the services necessary to collect and process the rental taxes for the Town of Geraldine, and the Town of Geraldine desires to accept such proposal.

THEREFORE, it is **RESOLVED** by the Geraldine Town Council and Mayor as follows:

1. That the Town of Geraldine, Alabama shall begin self-collection and administration of Rental/Lease Tax beginning with the period of February, 2018 (with the first collection to be received on or before March 20, 2018); and
2. That the Mayor is instructed to notify the State of Alabama Department of Revenue immediately of the decision of this Council; and
3. That RDS will perform the services necessary to administer and collect the rental taxes for the Town as set forth in the attached Tax Revenue Enhancement Agreement for Revenue Administration, and such agreement hereby is accepted, and the Mayor is hereby authorized and directed to enter a contract with RDS which conforms to such proposal, and the Town Clerk is authorized and directed to attest the same.

Upon motion that this Resolution be approved and such motion being duly seconded, and the Resolution having passed by unanimous vote of the Council, and the Mayor declared the Resolution so passed.

This Resolution hereby amends and/or replaces any Ordinance of the Town of Geraldine, Alabama regarding rental tax which are contrary to this Resolution.

IN WITNESS WHEREOF, the MAYOR and TOWN COUNCIL of the TOWN OF GERALDINE, ALABAMA duly have adopted this Resolution and caused it to be executed by the officers below in duplicate on this 5th day of December, 2017.


