ORDINANCE NO. 196-02

AN ORDINANCE TO AMEND CHAPTER 5, ARTICLE VIII, SECTION 5-142 OF THE CODE OF ORDINANCES OF THE CITY OF PELHAM, ALABAMA TO MODIFY THE PRIVILEGE OR LICENSE TAX FOR THE BUSINESS OF RENTING OR FURNISHING ROOMS, LODGINGS, OR ACCOMMODATIONS TO TRANSIENTS

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Pelham, Alabama as follows:

Section 1. LODGING TAX LEVY MODIFIED

Chapter 5, Article VIII, Section 5-142 Levy and Amount of Tax of the Code of Ordinances of the City of Pelham, Alabama is hereby amended by deleting Section 5-142 in its entirety and replacing it with the following:

Sec. 5-142.-Levy and amount of tax.

There is levied and imposed, in addition to all other taxes of every kind now imposed by law, a privilege or license tax upon every person, firm, or corporation engaging in the business of renting or furnishing any room or rooms, lodging, or accommodations to transients in any hotel, motel, inn, tourist camp, tourist cabin, or any other place in which rooms, lodgings, or accommodations are regularly furnished to transients for a consideration at the rate of six percent (6%) of the charge for such room, rooms, lodgings, or accommodations, including the charge for use or rental of personal property and services furnished in such room.

The proceeds collected related to this ordinance shall be expended to support the general operations of the City of Pelham, the Pelham Commercial Development Authority, and the employment of an economic development professional as directed and appropriated by the City Council.

Section 2. SEVERABILITY

Each section and provision of this ordinance is hereby declared to be an independent section or provision. If any section or provision shall be declared void, invalid, or unconstitutional, the remaining sections or provisions shall not be affected but shall remain in full force and effect.

Section 3. EFFECTIVE DATE

This ordinance shall become effective on the first day of April 2016.
