TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption, engaged in the business of leasing or renting tangible personal property, in the Town of Fort Deposit, Alabama and its police jurisdiction (located in Lowndes County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the Town of Fort Deposit has adopted Resolution No. 031422 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, rental taxes, for the Town of Fort Deposit. This Resolution is effective June 01, 2022.

Therefore, your first Town of Fort Deposit local tax return filed with Alabama Department of Revenue is for the tax period ending June 30, 2022, which is due on or before July 20, 2022. These taxes are to be reported using the Local Tax return in My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>. 
**BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF FORT DEPOSIT OF  
LOWNDES COUNTY, ALABAMA, AS FOLLOWS:**

SECTION 1. Administration and Collection by Alabama Department of Revenue. Pursuant to the provisions of the Code of Alabama 1975, Section 11-51-207, the TOWN OF FORT DEPOSIT of Lowndes County hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all sales, consumers use, sellers use, rental, and lodgings taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law.

SECTION 2. Certified Copy. The Town of Fort Deposit of Lowndes County, Alabama shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution beginning on JUNE 1, 2022.

The Town of Fort Deposit of Lowndes County, Alabama adopted this Resolution at the regular meeting on March 14, 2022. This Resolution is effective as of June 01, 2022.
