Taxpayers are <u>now</u> required to renew the state of Alabama tax license by December 31 of each year, through MAT, for the tax accounts listed below:

- Sales Tax
- Rental Tax
- Sellers Use Tax
- Simplified Sellers Use Tax
- Lodgings Tax
- Utility Gross Receipts Tax

The new owner(s) needs to apply under their SSN or EIN.)
