

**ORDINANCE NO. 2022-26****An Ordinance to Amend Chapter 82, Taxation, Article III Business License Code, Section 82-73 of the Alexander City Code as it Pertains to the License Classifications**

**BE IT ORDAINED** by the City Council of the City of Alexander City, Alabama, as follows:

**SECTION 1.** That Section 82-73, License Classifications, be amended to read as follows:

**SECTION 2.** Amend Section 82-74 state the following:

**Business License Issuance Fees**

The City of Alexander City will charge the maximum amount for the business license issuance fee based on Section 11-51-90, Code of Alabama 1975, and Departmental Rule 810-8-5-.15.

**SECTION 3.** If any paragraph, section, subsection, or provision of this ordinance be declared invalid in a court of competent jurisdiction for any reason, it shall not affect the remainder of the ordinance as pertains to its validity or to other applications.

**SECTION 4.** Any ordinance or provisions of ordinances in conflict with the provisions of this ordinance are hereby repealed and rescinded insofar as they conflict with the provisions of this ordinance, including Section 82-74.

This ordinance will be published in compliance with Section 11-45-3, Code of Alabama 1975.

This ordinance shall become effective January 1, 2023.

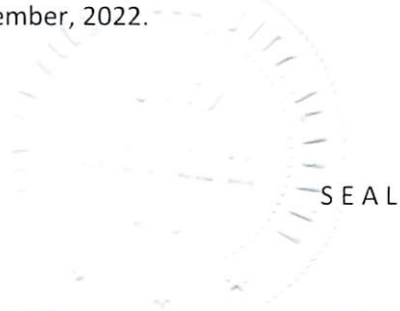



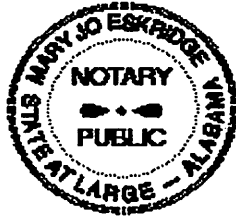
