| Whereas, Town of Snead, Alabama desires to begin self-collection and administration of Town Sales/Use Tax and Rental Tax and any other additional taxes effective beginning the period of December 1, 2022 (with the first collection to be received on or before January 20, 2023); and |
| Whereas, Town of Snead, Alabama has been presented a proposal by AVENU INSIGHTS & ANALYTICS of Birmingham dated September 26, 2022, whereby AVENU INSIGHTS & ANALYTICS will perform the services necessary to administer and collect the taxes for the Town and the Town desires to accept such proposal. |
| NOW THEREFORE BE IT RESOLVED by the Town of Snead Council that the Town agrees to begin collecting Town sales/use tax and rental tax effective beginning with the period of December 1, 2022 with taxes due by June 20th the Mayor is instructed to notify the State of Alabama Department of Revenue immediately of the decision of this Council; and |
| BE IT FURTHER RESOLVED that the proposal presented by AVENU INSIGHTS & ANALYTICS dated September 26, 2022, whereby AVENU INSIGHTS & ANALYTICS will perform the services necessary to administer and collect the taxes for the City, be accepted and the Mayor is hereby authorized and directed to enter a contract with AVENU INSIGHTS & ANALYTICS which conforms to such proposal. |
| THEREFORE, Phillip MeHan, a Council member, made the motion and hay Thomas, a Council member, seconded the motion that said resolution be approved, and said resolution passed by majority vote of the Council, and the Mayor declared the Resolution so passed. |
