ORDINANCE No. 2022-24

Local Tax Section Alabama Dept. of Revenue An Ordinance to Establish a \$2.00 Lodging Fee in the City of Clanton, Alabama

WHEREAS, the City Council of the City of Clanton, Alabama determined it served a public purpose to levy a lodging tax rate of four (4) percent within the Clanton, Alabama corporate limits by adopting Ordinance No. 7-89; and

WHEREAS, the Clanton City Council determined it served a public purpose to increase said lodging tax rate by two (2) percent for a total rate of six (6) percent by adopting Ordinance No. 2021-04 on April 26, 2021, effective on July 1, 2021; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Clanton, Alabama that the Council hereby authorizes the addition of subsections, specified herein, to the City of Clanton Code of Ordinances, Section 10-332 – Levy, as follows:

- (c) In addition to the business privilege license fee and the municipal lodging tax rate, there shall be an additional \$2.00 lodging fee per occupied room, per night, levied on the charge for any room(s) or lodging(s), including campgrounds, within the corporate limits of Clanton, Alabama.
- (d) The additional \$2.00 lodging fee collected under subsection (c) shall be considered general fund monies but will predominantly be used for economic development purposes.

BE IT FURTHER ORDAINED by the Clanton City Council that Ordinance No. 2022-24 and the applicable \$2.00 lodging fee shall become effective on February 1, 2023, as authorized by State of Alabama Act 2018-150.

BE IT FURTHER ORDAINED by the Clanton City Council that each of the provisions of this Ordinance are considered severable and if any provision is declared to be invalid, the remaining provisions shall not be affected but shall remain in full force.

BE IT FURTHER ORDAINED by the Clanton City Council that all Ordinances, parts of Ordinances, or any other language conflicting with the intent of Ordinance No. 2022-24 is hereby amended, revised, or otherwise repealed.
