## FINISHING BASE CONFIGURATION

This month, the ALVIN project team has been wrapping up the foundational elements of the system and finalizing a base configuration. These elements will be presented to management and the steering committee on March 13th, putting us right on schedule. This base configuration provides the structure for primary processes like title application, dealer registration, and fee calculations.
