VESSEL TITLING REMINDER

Legislative Act 2022-144 establishes the Uniform Certificate of Title for Vessels Act. The act provides requirements for owners of certain vessels to obtain certificate of title. Licensing Officials are authorized by this act to be agents of the department in assisting with the applications for title. **The act takes effect January 1, 2024**, and more information regarding its implementation will be provided at a later date. For further information, reference to Alabama Senate Bill 211.

ALVIN IS INTEGRATED

One of the benefits of ALVIN is it's replacement and integration of many existing systems. This is beneficial for those working in MVTRIP and the general public. It is meant to cut down on confusion and make processes simpler and streamlined. ALVIN is replacing ALTS, ETAPS, MVTRIP, AIMS, PROS, MVDOC, MVD License Portal, SCRAP Portal, Public Portal, Unclaimed/Abandoned Portal, and the Involuntary Transfer Portal.

ALVIN is a browser-based system which means it's accessed through your internet browser.
