PROJECT MILESTONES

As rollout draws ever closer, the ALVIN team continues to press on and get stuff done!

- ALDOR testers came on board on May 8, have been successfully testing for several weeks.
- Our Conversion team has completed their first "mock" conversion. This means that they have practiced taking all the data from the Legacy system and loading it into ALVIN. This helps the project by enabling us to find and fix errors early on, rather than waiting until we go live in December.
- The Training team is onboarding agency trainers on June 6. These trainers will spend the next few months building the curriculum and getting ready for training in October.

FUNCTIONALITY CORNER

ALVIN has some exciting functionality to help you do your job more effectively. This month, we'd like to highlight customizing lists.

In nearly every list in ALVIN, whether it be on a report or a customer record, you can apply **custom sorts** and **filters**, and even modify what type of information is displayed.

Once you have the information you want, you can **export** it to an Excel spreadsheet to send it to someone else or modify it further.

MONTHLY FAQ

What resources do we have when we need help?

Your first line of support is ALVIN's built-in Help system. This system is comprised of hundreds of Help Topics that walk you through a process, step-by-step.

These Help Topics can be accessed easily in the applicable place in the system. This is known as context help. They can also be searched using keywords.

ALVIN TERMINOLOGY

With the transition to the new system, there are some terms and concepts that we want you to become familiar with before ALVIN's rollout. Let's explore one together! Conversion is taking information from the Legacy systems and loading it into ALVIN in a way that will allow it to be used. This requires purification (cleaning up) of bad or incomplete data, which could be anything from missing information to account numbers with the wrong number of digits.
