5	40-18-417.8 to the Code of Alabama 1975; to provide that the
6	credit from a parent or holding company may be claimed by the
7	subsidiary in certain circumstances; and to provide
8	retroactive effect.
9	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
10	Section 1. Section 40-18-417.8 is added to the Code of
11	Alabama 1975, to read as follows:
12	§40-18-417.8
13	(a) Notwithstanding the provisions of subsection (f) of
14	Section 40-18-417.4, for tax years beginning on or after
15	January 1, 2021, the credit issued to a parent or holding
16	company may be claimed by the subsidiary, provided both parent
17	or holding company and subsidiary are filing as part of an
18	Alabama consolidated return.
19	(b) The Department of Revenue may adopt rules for the
20	implementation and administration of this act.
21	Section 2. This act shall become effective immediately
22	following its passage and approval by the Governor, or its
23	otherwise becoming law.
