- The training team has onboarded 8 agency trainers to create curriculum for all Licensing Official and internal MVD users.

CHANGE CORNER

With a new system comes new process changes. This month, we'd like to highlight some details about NMVTIS.

- NMVTIS stands for National Motor Vehicle Title Information System. It allows jurisdictions to share title information to help prevent mistakes and fraud.
- In MVTRIP, NMVTIS was run manually on a case by case basis. In ALVIN, NMVTIS will run on every title transaction before it can be submitted.

MONTHLY FAQ

How do we keep everything secure in ALVIN?

With the rollout of ALVIN, it will be expected that everyone uses their own unique username and password. ALVIN keeps track of which user performs which transaction, so it's in your best interest to not share your login with anybody else.

Remember that sharing is caring except when it comes to your password!
