TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption, engaged in the business of leasing or renting tangible personal property, engaged in the renting or furnishing of rooms, lodgings, or accommodations made to transients, in the Town of Butler, Alabama and its police jurisdiction (located in Choctaw County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the Town of Butler has adopted Resolution No. 389 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, rental taxes, lodging taxes, for the Town of Butler. This Resolution is effective October 01, 2023.

Therefore, your first Town of Butler local tax return filed with Alabama Department of Revenue is for the tax period ending October 31, 2023, which is due on or before November 20, 2023. These taxes are to be reported using the Local Tax return in My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>. A RESOLUTION AUTHORIZING THE ALABAMA DEPARTMENT OF REVENUE TO ADMINISTER, AND COLLECT SALES, USE, RENTAL, AND LODGING TAXES LEVIED BY THE TOWN OF BUTLER.

STATE OF ALABAMA


BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BUTLER, AS
FOLLOWS:

SECTION 1: Administration and Collection by State Department of Revenue. Pursuant to the provisions of Code of Alabama 1975, Section 11-51-207, the Town Council of the Town of Butler hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all *sales, use, rental and lodging* taxes levied and assessed under the provision of this Resolution to the fullest allowed by Alabama law.


SECTION 2: The Town of Butler shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provision of this Resolution.

The Town Council of the Town of Butler adopted this Resolution at the regular meeting on July 11, 2023.

This Resolution is effective as of the October 1, 2023.
