- SUBJECT: Act 2023-162 Brain Cancer Research Act 2023-230 Emergency Medical Service Provider Act 2023-498 Air Medal Act 2023-513 Marine Corps & Space Force Act 2023-516 Operation Inherent Resolve Children's of Alabama

During the 2023 legislative session, five Acts were enacted into law related to the distribution and reporting of the additional annual fees collected on the following license plate categories. Tag types and availability will be provided by the Department of Revenue. After the plates becomes available, the additional annual fees collected for these license plate categories should be distributed and reported on the monthly summary statement FRMS 5-A as follows:

Act 2023-162 authorizing the issuance of the Brain Cancer Research distinctive license plate.

Act 2023-230 providing for new distribution of proceeds on the sales of the Emergency Medical Service Provider (EMSP) distinctive license plate. Effective January 1, 2024, proceeds for this license plate category will no longer be distributed to the State General Fund.

Starting with EMSP tags sold in your office during November 2023, disbursed to the State in December 2023, distribute and report on the monthly summary statement FRMS 5-A as follows:
