The City of Lanett (located in Chambers County) has notified the Department of Revenue that they have eliminated the police jurisdiction outside the corporate limits of the city effective January 1, 2024.

In conjunction with the police jurisdiction elimination, the Chambers County PJ Lanett (7209) tax rates will be ceased effective December 31, 2023 and the Chambers County Unincorporated Areas (7109) tax rates will apply for that area effective with the January 2024 taxes due on or before February 20, 2024.

The Chambers County Unincorporated Areas (7109) tax rates are as follows:

Admissions to places of amusement and entertainment .....	6.000
Retail Selling Price of food for human consumption sold through vending machines .....	6.000
Net difference paid for machines, machinery, and equipment used in planting, cultivating and harvesting farm products .....	2.500
Machines and parts and attachments for machines used in manufacturing tangible personal property .....	2.500
Net difference paid for all automotive vehicles, truck trailers, semi-trailers and house trailers .....	2.500
Withdrawal fee for automotive vehicle dealers only .....	2.50

# Ordinance 09-23-01

## CITY OF LANETT, ALABAMA

### AN ORDINANCE TO ELIMINATE MUNICIPAL POLICE JURISDICTION IN THE CITY OF LANETT


WHEREAS, pursuant to Section 11-40-10 of the Alabama Code, the City of Lanett may reduce or eliminate its police jurisdiction outside the corporate limits; and


WHEREAS it is no longer economically feasible to provide services to those located in the police jurisdiction outside the corporate limits of the City of Lanett.

NOW, THEREFORE BE IT ORDAINED, by the Lanett City Council of the City of Lanett, Alabama as follows:

The police jurisdiction outside the corporate limits of the City of Lanett is hereby eliminated and all services to those located outside the municipal corporate limits will cease effective January 1, 2024.
