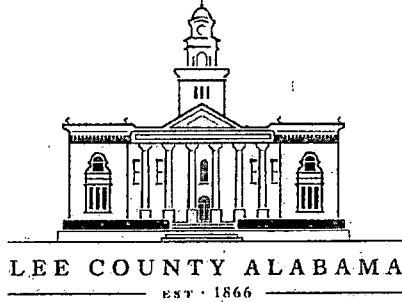

RESOLUTION AUTHORIZING AVENU INSIGHTS AND ANALYTICS, LLC TO ADMINISTER AND COLLECT CABLE FRANCHISE, VIDEO RENTAL, SALES & USE, SEVERANCE, AND ALCOHOL TAXES LEVIED BY LEE COUNTY

STATE OF ALABAMA

WHEREAS, Section 11-51-207 of the Code of Alabama 1975, allows for Avenu Insights and Analytics, LLC to administer and collect taxes; and
