TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption, engaged in the business of leasing or renting tangible personal property, in the City of Tarrant, Alabama (located in Jefferson County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the City of Tarrant has adopted Resolution No. 9053 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, rental taxes, for the City of Tarrant. This Resolution is effective April 01, 2024.

Therefore, your first City of Tarrant local tax return filed with Alabama Department of Revenue is for the tax period ending April 30, 2024, which is due on or before May 20, 2024. These taxes are to be reported using the Local Tax return in My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>. RESOLUTION NO. 9053

A RESOLUTION AUTHORIZING THE ALABAMA  
DEPARTMENT OF REVENUE TO ADMINISTER AND  
COLLECT SALES, USE, RENTAL AND LODGINGS TAXES  
LEVIED BY THE CITY OF TARRANT

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TARRANT,  
ALABAMA, AS FOLLOWS:

SECTION 1. Administration and Collection by Alabama Department of Revenue. Pursuant to the provisions of the Code of Alabama 1975, Section 11-51-207, the City Council of the City of Tarrant, Alabama hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all sales, consumers use, sellers use, rental, and lodgings taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law.

SECTION 2. Certified Copy. The City of Tarrant, Alabama shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution beginning on January 1, 2024.
