TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption, engaged in the business of leasing or renting tangible personal property, engaged in the renting or furnishing of rooms, lodgings, or accommodations made to transients, in the Town of Pinckard, Alabama (located in Dale County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the Town of Pinckard has adopted Resolution No. 2024-04-30 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, rental taxes, lodging taxes, for the Town of Pinckard. This Resolution is effective August 01, 2024.

Therefore, your first Town of Pinckard local tax return filed with Alabama Department of Revenue is for the tax period ending August 31, 2024, which is due on or before September 20, 2024. These taxes are to be reported using the Local Tax return in My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>. LEVIED BY THE Town of Pinckard**


STATE OF ALABAMA

**BE IT ORDAINED BY THE TOWN COUNCIL OF TOWN OF PINCKARD, AS
FOLLOWS:**

SECTION 1. Administration and Collection by Alabama Department of Revenue. Pursuant to the provisions of the Code of Alabama 1975, Section 11-51-207, the Town of Pinckard hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all *sales, use, rental, and lodgings* taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law.


SECTION 2. Certified Copy. The Town of Pinckard shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution.

The Town of Pinckard adopted this Resolution at the regular meeting on April 16, 2024. This Resolution is effective as of August 1, 2024.
