BE IT ORDAINED BY THE CHEROKEE COUNTY COMMISSION OF CHEROKEE COUNTY, ALABAMA  
AS FOLLOWS:


SECTION 1. Administration and Collection by Alabama Department of Revenue. Pursuant to the provisions of the Code of Alabama 1975, Section 11-51-207, the Cherokee County Commission hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all sales, consumers use, sellers use, rental, and lodgings taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law.

SECTION 2. Certified Copy. The Cherokee County Commission shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution beginning on December 1, 2024.

The Cherokee County Commission adopted this Resolution at the regular meeting on October 15, 2024. This Resolution is effective as of October 15, 2024.
