- 16 corporation engaging in the business of renting or furnishing
- 17 any room/or rooms, lodging, or accommodations to a transient
- in any hotel, motel, inn, tourist camp, tourist cabin, or any
- other place in which rooms, lodgings, or accommodations are
- 20 regularly furnished to transients for a consideration. The
- 21 amount of the tax shall be equal to twofour percent of the
- 22 charge for the rooms, lodgings, or accommodations, including
- 23 the charge for use or rental of personal property and services
- 24 furnished in the room. There is exempted from the tax
- 25 authorized to be levied under this section any rentals or
- 26 services taxed under Article 1, Chapter 23, Title 40. Any
- 27 room, rooms, lodging, or accommodations does not include
- 28 recreational vehicles or campgrounds.
