TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption, in the Town of Skyline, Alabama and its police jurisdiction (located in Jackson County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the Town of Skyline has adopted Resolution No. 2025-005 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, for the Town of Skyline. This Resolution is effective August 01, 2025.

Therefore, your first Town of Skyline local tax return filed with Alabama Department of Revenue is for the tax period ending August 31, 2025, which is due on or before September 22, 2025. These taxes are to be reported using the Local Tax return in My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>. BE IT THEREFORE RESOLVED, ADOPTED, AND AFFIRMED as follows:


A) That the Town of Skyline hereby terminates its contract with Avenu Insights & Analytics for tax collecting services;


B) That the Alabama Department of Revenue shall be designated as the tax collecting entity for the Town of Skyline;


