ORDINANCE NO. 2025- 04

AN ORDINANCE RELATING TO THE LEVYING OF A PRIVILEGE OR LICENSE TAX AGAINST PERSONS, FIRMS, OR CORPORATIONS ENGAGING IN THE CITY OF WARRIOR, ALABAMA, IN THE BUSINESS OF RENTING OR FURNISHING ROOMS OR LODGING TO TRANSIENTS, PROVIDING FOR THE COLLECTION THEREOF; PROVIDING FOR THE MAINTENANCE AND EXAMINATION OF CERTAIN REQUIRED RECORDS; AND PROVIDING PENALTIES FOR THE VIOLATION OF THIS ORDINANCE ADOPTED BY THE CITY COUNCIL OF THE CITY OF WARRIOR, ALABAMA.

BE IT ORDAINED BY THE CITY COUNIL OF THE CITY OF WARRIOR ALABAMA AS FOLLOWS,
WHILE IN REGULAR SESSION ON THIS THE 17th DAY OF MARCH, 2025

SECTION 1. Lodging Tax levy; rate; exemptions.


- (a) For the privilege of engaging or continuing, within the city, in the business activities hereinafter referred to, there is hereby levied and imposed, in addition to all other taxes of every kind now imposed by law, and shall be collected as herein provided, a privilege or license tax against the person on account of the business activities and in the amounts to be determined by the application of rates against gross receipts upon every person, firm, or corporation engaging in the business of renting or furnishing any room or rooms, lodgings, or accommodations to transients in any hotel, motel, inn, tourist court, or in any other place or establishment in which rooms, lodgings or accommodations are regularly furnished to transients for a consideration in an amount to be determined by the application of the rate of nine (9%) percent of the charge for such room, rooms, lodgings, or accommodations, including the charge for use or rental of personal property and services furnished in such room.
- (b) Relationship to state law. This chapter and the taxes levied herein shall be subject to all definitions, exceptions, exemptions, proceedings, requirements, rules, regulations, provisions, penalties, fines, punishments and deductions that are applicable to the taxes levied pursuant to Code of Ala. 1975, 40-26-1 et seq. (the "Lodgings or Transient Occupancy Statutes"), except where inapplicable or herein otherwise provided.

SECTION 2. This Ordinance shall become effective on August 1, 2025, after its passage and publication and the first payment of taxes hereunder shall be due and payable on or before the 22nd day of September, 2025.


