TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption, engaged in the business of leasing or renting tangible personal property, in the Town of Snead, Alabama (located in Blount County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the Town of Snead has adopted Resolution No. 2025-0915-0R1 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, rental taxes, for the Town of Snead. This Resolution is effective December 01, 2025.

Therefore, your first Town of Snead local tax return filed with Alabama Department of Revenue is for the tax period ending December 31, 2025, which is due on or before January 20, 2026. These taxes are to be reported using the Local Tax return in My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>. **A RESOLUTION AUTHORIZING THE ALABAMA DEPARTMENT
OF REVENUE TO ADMINISTER AND COLLECT SALES, RENTAL,
CONSUMERS USE & SELLERS USE TAXES LEVIED BY
THE TOWN OF SNEAD**

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF SNEAD, AS FOLLOWS:

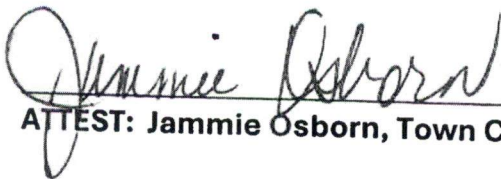
SECTION 1. Administration and Collection by Alabama Department of Revenue.
Pursuant to the provisions of the Code of Alabama 1975, Section 11-51-207, the Town of Snead, Alabama hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all (sales, consumers use, sellers use and rental) taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law.

SECTION 2. Certified Copy. The Town Council of the Town of Snead shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution beginning on December 1, 2025.

The Town Council of the Town of Snead adopted this Resolution at the regular meeting on September 15, 2025. This Resolution is effective as of September 15, 2025.
