Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the City of Haleyville has adopted Resolution No. 2025-52 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, rental taxes, for the City of Haleyville. This Resolution is effective January 01, 2026.

Therefore, your first City of Haleyville local tax return filed with Alabama Department of Revenue is for the tax period ending January 31, 2026, which is due on or before February 20, 2026. 

WHEREAS, The City of Haleyville shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by the Alabama Department of Revenue to enable it to administer and collect taxes levied and accessed under the provisions of this resolution.

NOW THEREFORE BE IT RESOLVED, that the City Council of the City of Haleyville, Alabama, hereby authorizes the Alabama Department of Revenue to administer and collect sales, use, rental, and lodging tax levied by the City of Haleyville.


