Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the City of Semmes has adopted Resolution No. 2025-97 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, rental taxes, lodging taxes, for the City of Semmes. This Resolution is effective January 01, 2026.

Therefore, your first City of Semmes local tax return filed with Alabama Department of Revenue is for the tax period ending January 31, 2026, which is due on or before February 20, 2026. These taxes are to be reported using the Local Tax return in My Alabama Taxes (MAT) at https://myalabamataxes.alabama.gov.
