THE COUNTY OF WALKER**


BE IT ORDAINED BY THE WALKER COUNTY COMMISSION AS FOLLOWS:

SECTION 1. Administration and Collection by Alabama Department of Revenue.

Pursuant to the provisions of the Code of Alabama 1975, Section 11-51-207, Walker County, by and through Walker County Commission, hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all sales, consumer use, sellers use, rental, lodgings, tobacco, alcohol, and motor fuels taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law.


SECTION 2. Certified Copy. Walker County shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution beginning ninety (90) days from the date of this Resolution on the 1 day of October, 2025.
