Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the City of Westover has adopted Resolution No. 2025-08-05-2109 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, rental taxes, lodging taxes, for the City of Westover. This Resolution is effective January 01, 2026.

Therefore, your first City of Westover local tax return filed with Alabama Department of Revenue is for the tax period ending January 31, 2026, which is due on or before February 20, 2026. ## STATE OF ALABAMA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WESTOVER, ALABAMA IN SHELBY COUNTY, ALABAMA, AS FOLLOWS:

SECTION 1. Administration and Collect by Alabama Department of Revenue. Pursuant to the provisions of the Code of Alabama 1975, Section 11-51-207, the City of Westover, Alabama in Shelby County, Alabama hereby directs that the Department of Revenue of the State of Alabama shall administer and collect all sales, consumers use, sellers use, rental and lodgings taxes levied and assessed under the provisions of this Resolution to the fullest extent allowed by Alabama law.

SECTION 2. Certified Copy. The City of Westover, Alabama in Shelby County, Alabama shall provide a certified copy of this Resolution to the Alabama Department of Revenue and shall also provide such other information and take such other steps as may be required by said Alabama Department of Revenue to enable it to administer and collect taxes levied and assessed under the provisions of this Resolution beginning on <u>January 1, 2026</u>.
