TO: ALL PERSONS, FIRMS, AND CORPORATIONS making sales at retail and/or purchasing tangible personal property for use, storage or other consumption, engaged in the business of leasing or renting tangible personal property, in the Town of Eva, Alabama (located in Morgan County).

Article 3, Chapter 51, Title 11, et seq., Code of Alabama, 1975 authorizes and empowers municipalities to levy a true sales, use, rental and lodgings tax identical to the corresponding State Tax Laws except for the rates of tax.

The governing body of the Town of Eva has adopted Resolution No. 26-01-01 to commence services rendered by the Alabama Department of Revenue in the administration and collection of the sales/use taxes, rental taxes, for the Town of Eva. This Resolution is effective May 01, 2026.

Therefore, your first Town of Eva local tax return filed with Alabama Department of Revenue is for the tax period ending May 31, 2026, which is due on or before June 22, 2026. These taxes are to be reported using the Local Tax return in My Alabama Taxes (MAT) at <https://myalabamataxes.alabama.gov>. **A RESOLUTION AUTHORIZING THE ALABAMA
DEPARTMENT OF REVENUE TO ADMINISTER AND
COLLECT (SALES, USE, AND RENTAL) TAXES
LEVIED BY THE TOWN OF EVA**

STATE OF ALABAMA

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF EVA,
ALABAMA, AS FOLLOWS:

**SECTION 1. Administration and Collection by Alabama Department of
Revenue.**

Pursuant to the provisions of Section 11-51-207 of the Code of Alabama 1975, as amended, the
Town of Eva hereby authorizes and directs the Alabama Department of Revenue to administer
and collect all sales, consumers use, sellers use, and rental taxes levied and assessed under the
provisions of this Resolution to the fullest extent allowed by Alabama Law.

SECTION 2. Certified Copy.

The Town of Eva shall provide a certified copy of this Resolution to the Alabama Department of
Revenue and shall provide such additional information and take such further actions as may be
required by the Department of Revenue to enable it to administer and collect the taxes authorized
herein, beginning on May 1, 2026.

This Resolution was adopted by the Mayor and Council of the Town of Eva at a regular meeting
held on January 13th, and shall become effective on January 13th 2026

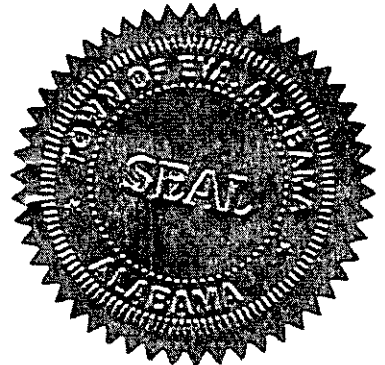
