**ORDINANCE ASSENTING TO THE ANNEXATION OF CERTAIN PROPERTY OR TERRITORY
TO THE CITY OF ARAB, ALABAMA, PURSUANT TO THE SECTIONS 11-42-20
THROUGH-11-42-24, INCLUSIVE, CODE OF ALABAMA (1975).**

WHEREAS, the owner(s) of the herein described property, 1891 Friendship Road, owners Rick Laster and Dusty Laster, has petitioned the governing body of the City of Arab, Alabama, requesting that said property be annexed to the City of Arab, Alabama; and,

WHEREAS, the City Clerk of the City of Arab has verified that: Said petition contained the signature of the authorized representative of the owner of the property as the same is assessed for ad valorem tax purposes; and, all property described herein is contiguous to the present city limits of the City of Arab, Alabama, and any portion of same lying within the police jurisdiction of another municipality does not lie any closer to the corporate boundary of said municipality than a line equidistant between the said municipality and the City of Arab, Alabama; and, a map of said territory showing its relationship to the corporate limits of the City of Arab has been filed with the City Clerk; and,

WHEREAS, it is the judgment and opinion of the City Council of the City of Arab, Alabama, that it is necessary and proper and in the public interest that said property be brought within the corporate limits of the City of Arab, Alabama; and, that said annexation is in accordance with Sections 11-42-20 through 11-42-24 of the Code of Alabama;

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ARAB, ALABAMA AS FOLLOWS:

1. That the City Council hereby assents to the annexation of certain property to the City of Arab, Alabama, more particularly described as follows:

Beginning at a point 298 ft West of the NE corner of the SE ¼ of the SE ¼ of Section 12, Township 8 South, Range 1 East of the Huntsville Meridian; thence East along the North line of said forty 150 ft to the NW corner of the lot of Jess A. Hornsby; thence South parallel with the East line of said forty to the North right of way of public road 250 ft; thence along the NW right of way of said road South 50 degrees West 150 ft; thence North 8 degrees 35' West 337.3 ft to the point of beginning in Marshall County, AL, subject to the right of way of said road.

ALSO: Beginning at a point which is located West 148.0 ft and South 132.3 ft from the NE corner of the SE ¼ of the SE ¼ of Section 12, Township 8 South, Range 1, East, Marshall County, AL; thence from the point of beginning South 10 degrees 41' East 103.42 to a point on the West margin of a county road; thence along the West margin of said road South 50 degrees West 25 ft to a point; thence North 117.7 ft to the point of beginning,

LESS AND EXCEPT, A small tract of land described as follows: Beginning at a point which is located West 148 ft from the NE corner of the SE ¼ of the SE ¼ of Section 12, Township 8 S, Range 1 East, Marshall County, AL; thence from the point of beginning South 132.3 ft to a point, thence North 10 degrees 41' 134.64 ft to a point, thence East 25 ft to the point of beginning.

2. That said parcel of land is hereby annexed as an R-1 (Low-Density Residential) zoning district and that the boundary lines of the City of Arab are hereby altered and rearranged so as to include all the territory indicated herein as being encompassed by the corporate limits of the City of Arab.
3. That said annexation and zoning become effective upon adoption and publication of this ordinance in accordance with law.
4. A copy of this Ordinance shall be delivered to the Marshall County Probate Judge.
