WHEREAS, Towanda Miller and Kellicia Bell, the owners of the hereinafter described property, did, in writing, petition the City of Dora, a municipal corporation, for annexation under Section 11-42-21 of the Code of Alabama, 1975, as amended; and

NOW, THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF Dora, ALABAMA, that the following described property, lying contiguous to the corporate limits of the City of Dora, Alabama; and not within the corporate limits or the police jurisdiction of any other municipality; be and the same is hereby annexed to the City of Dora, Alabama, to-wit:



From the Southwest corner of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 32, Township 15 South, Range 5 West, run East along the South line of the forty for a distance of 384.3 feet; thence North 8 degrees and 38 minutes West for a distance of 30.2 feet to the point of beginning; thence North 88 degrees and no minutes East for a distance of 117.0 feet; thence North 8 degrees and 38 minutes West for a distance of 134.0; thence Southwesterly for a distance of 117.0 feet more or less to a point; thence South 8 degrees and 38 minutes East for a distance of 111.0 feet to the point of beginning. All being in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 32, Township 15 South, Range 5 West, Walker County, Alabama.
Containing 0.33 acres more or less.


This Ordinance shall take effect immediately upon its due adoption and publication as required by law.

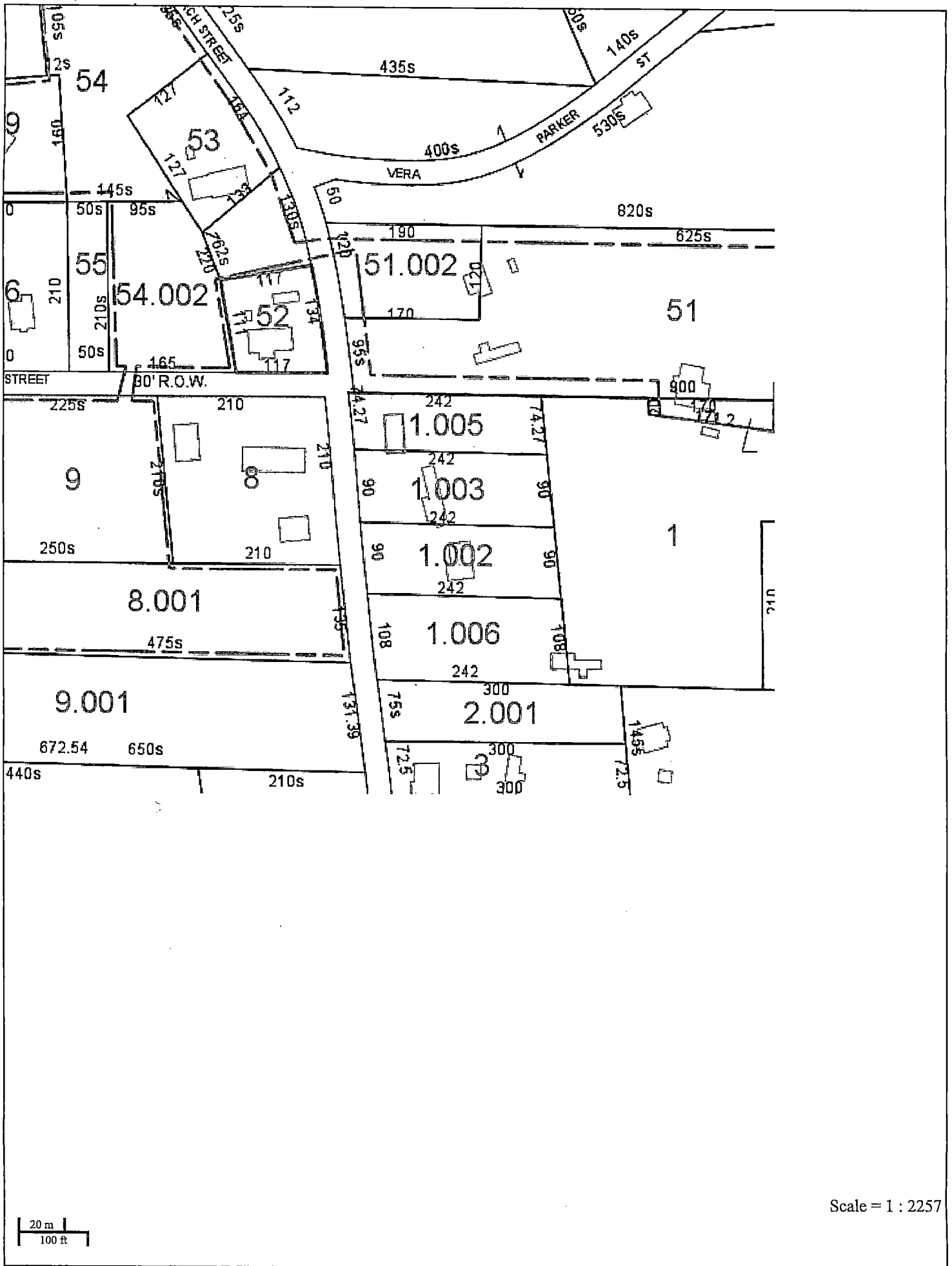
