


This Ordinance shall take effect immediately upon its due adoption and publication as required by law.

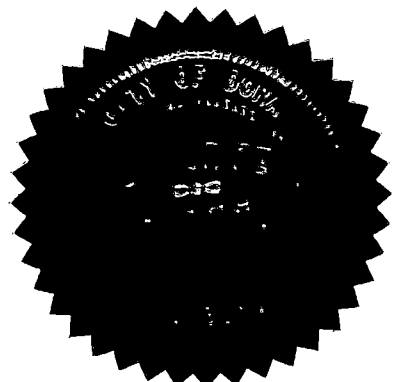

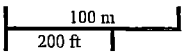

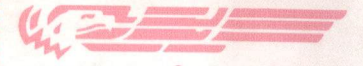
